
### Study Background



## "The Church should have a strong influence in the State of Utah"



### "The Church currently has a strong influence within the State of Utah."




#### "The Church is too involved in Utah Politics."

# "In the last five years, would you say the influence of the Church on Utah politics is . . . "








#### **Bishops**






# "Have you seen any messages from the Church regarding its position on Utah's alcohol laws?"




# [Of those who have seen any Church message:] "Have you seen a video featuring one of the Apostles regarding Utah's alcohol laws?"




# "In terms of economic impact on the state, do you think that Utah's alcohol laws have a . . ."







#### Perceived Influence of the Church

- 1. About the same percentages of Utah stake presidents and bishops who <u>agreed</u> that the Church has a strong influence in Utah also <u>agreed</u> that the Church **should** have a strong influence in Utah. However for active adults, 70% <u>agreed</u> that the Church currently has a strong influence but only 54% <u>agreed</u> that the Church **should** have a strong influence.
- 2. High percentages of Utah stake presidents (87%), bishops (73%), and active adults (71%) disagreed that the Church is too involved in Utah politics. Only 2% to 6% agreed.

#### Perceived Influence of the Church (continued)

3. Roughly 1/2 of Utah stake presidents, bishops, and active adults say the influence of the Church in Utah politics is "about the same" over the last 5 years, another 1/3 say it is "decreasing," and about 1/5 say it is "increasing."

#### **Perceptions of the Utah State Legislature**

4. Utah stake presidents, bishops, and active adults <u>agreed</u> that the Utah State Legislature takes into account the views of "the hospitality/tourism industry," "their constituents," and "teachers/educators" the most. They <u>agreed</u> that the legislature take into account the views of "the LDS Church," "news medial/editorial writers," and "minorities" the least.

#### **Awareness of Church Messages about Utah Alcohol Laws**

- 5. A high percentage of Utah stake presidents (76%) have seen a message(s) from the Church regarding its position on Utah's alcohol laws. A significantly lower percentage of Utah bishops (21%) and active adults (21%) saw a Church message(s) on this topic!
- 6. Conversely, of the 76% of Utah stake presidents who saw a message(s), only 13% said they saw a video featuring one of the Apostles! Slightly over 1/3 of Utah bishops and active adults said they saw a video featuring an Apostle.

#### **Awareness of Church Messages (continued)**

- 7. Roughly 1/3 of Utah bishops and active adults think that Utah's alcohol laws have a positive economic impact on Utah, another 1/3 think they have a negative economic impact, and the final 1/3 say they don't know.
- 8. High percentages of Utah stake presidents, bishops, and active adults <u>agreed</u> that they "support the Church in maintaining Utah's current alcohol laws" (75% to 90%), that "preserving Utah's alcohol laws is important to them" (70% to 82%), and that "Utah's alcohol laws improve public safety within the state" (74% to 85%). But a lower percentage <u>agreed</u> that "Utah's alcohol laws benefit the reputation of the state" (54% to 62%).
