## Re: Copyright infringement by mormonleaks.io

Dear Sirs:

I represent the heirs of Bruce R. McConkie in intellectual property matters.

- 1. My client is the owner of copyright in certain unpublished works authored by Bruce R. McConkie, including, without limitation, certain unpublished book manuscripts, unpublished articles, and unpublished notes. Some of these works were authored prior to January 1, 1978. However, under 17 U.S.C. § 302-303, copyright subsists in all of these unpublished works for a period ending 70 years after the death of Bruce R. McConkie, namely, through December 31, 2055.
- 2. The website mormonleak.io has reproduced and is distributing these unpublished works without permission, license, or authorization, contrary to the provisions of the U.S. Copyright Act. The list of 37 specific URLs below identifies the posted location of the infringing materials.
