Thank you for your service in caring for the poor and needy. To assist priesthood leaders in administering welfare services, we periodically review fast offering expenditures to identify apparent irregularities. In a recent review of fast offering expenditures of the La Donna Mesa Ward the following was noted:

Check issued directly to the recipient instead of to the provider of the goods or services:
Check [REDACTED] in the amount of \$1,065.00 was made payable directly to the recipient instead of to the provider of the goods or services; the purpose listed was "Car Insurance - Reimbursement."

We invite you to discuss this matter with Bishop [REDACTED] to satisfy yourself that correct principles and procedures are being followed, and provide training as needed. The instruction manual, "Providing in the Lord's Way", and section 5 (Administering Church Welfare) of *Handbook 1* are good resources to review. You may wish to counsel together with Elder [REDACTED] Seventy, who has also been copied on this letter.
